

Apart from regular lectures, following activities are conducted for overall development of students. The activities are curricular, co-curricular and extra curricular like:

- Circulation Club – The activity involves collecting of real world information relating to subjects under study and topics relating to current trends of management. The information is defused through common display board for benefit of all.
- Cultural Activity Club – Students are encouraged to take part in various competitions in house as well as in other institutions. Students participate in elocution, chess, brainstorming and management quiz, management games, role play, paper presentation, case studies, product launching, marketing warfare, and personality contest.

X. CRITERIA AND WEIGHTAGES FOR ADMISSION

ADMISSION PROCESS

1. Admissions to allottees for the Institute – After the display of allotment list in CAP round, candidate should report to the institute for admission with original documents. After scrutiny of original documents, the candidate will have to fill up the form in Information Brochure of our Institute and pay prescribed full fees immediately and confirmed the admission offered. If the candidate fails to do so in prescribed time his/her claim for admission shall be forefitted.
2. Admissions to seats remaining vacant after offering admissions through CAP –

The seats remaining vacant after admissions through CAP strictly on the basis of inter se merit of the candidates shall be offer to candidates having Maharashtra Candidature first. After admitting Maharashtra candidates, if seats still remain vacant then the seats would be offered to eligible OMS candidates.

Aspiring candidates fulfilling the eligibility criteria shall apply directly to the Principal/ Director of the Institute for admissions. These admissions will be made in a transparent manner and strictly as per the merit of the candidates who have applied to the institute. Institute shall display the merit list on their notice boards prior to admissions.

The vacancies in backward class category seats within sanctioned intake shall be filled with reference to Inter se merit of the respective backward class category candidates.

THE MAH-MBA/MMS-CET 2021

- The question paper for the CET will be set in English only. Translations in any languages will not be available.

- The CET would be of 2 ½ (TWO and Half) hours duration and would have a maximum of 200 marks.
- The CET would have multiple choice objective type questions.
- The CET would not have negative marking.
- There will be no verification of marks or revaluation of answer sheets of the CET.
- The marks at the CET would be considered for admission during the current academic year only and would not be allowed to be carried forward to the next year.
- The venues allotted to the various candidates admitted to the CET would be displayed on web site – www.mahacet.org.in/mba under the heading MBA/MMS CET Examination .

The allotment of seats is done through the computer as per inter se the merit of the candidates, options filled by the candidates and the availability of seats at that point of the time during the process of allotment.
